Note: If your child began his school year in another setting, the days he has already attended count toward his total for this academic year. In other words, if your child already attended 50 days of school at his local public school before withdrawing, he now needs to complete 130 days of home instruction to meet the 180 days requirement, by a date no later than one year from the date he started school in his previous institution.

If your child has been withdrawn from your local district's home education program mid-year in order to register with Deer Chase Academy, his school attendance is counted in the same manner.
